D. Important Notes

- 1. The costs charged pursuant to this Schedule are intended to help the Lancaster County Tax Collection Bureau obtain reimbursement for the out-of-pocket and internal costs of collecting delinquent taxes.
- 2. Typically, costs assessed against employers are higher than those assessed against individual taxpayers. The reason that is so is because it takes the Lancaster County Tax Collection Bureau longer to review and process an employer file.
- 3. All costs authorized in this Schedule are in addition to any interest and penalties assessed against delinquent taxpayers and employers pursuant to the Local Tax Enabling Act and the Lancaster County Tax Collection Bureau Rules and Regulations.
- 4. In addition to collection costs assessed under this Schedule and interest and penalties, the Lancaster County Tax Collection Bureau is entitled to assess and recover all costs incurred in engaging a collection agency, auditor, legal counsel, or other professional consultant to assist with collecting delinquent tax from individuals and employers.
- 5. All costs in this Schedule are cumulative. For example, if an employer fails to respond to a first notice but then responds to a second notice by setting up a payment plan, the employer will be obligated to pay a total of \$200 in up front collection costs (i.e., \$50 + \$100 + \$50 = \$200) plus a \$25 per payment fee thereafter.
